We know choosing a nursery is a big decision and understanding how funding works can feel a little overwhelming at first. The great news is that there is a wide range of government support available to help make high quality early education more affordable for your family. Whether you are a first time parent or navigating new entitlements, there is likely a scheme that can work for you. To make things easier, we have pulled everything together in one place, clearly explained and simply laid out

30 hours funded childcare for eligible working families



Tell me more...

If you live and work in England you may be entitled to 30 hours funded childcare support from the term after your child turns 9 months old, until they start school. We can offer your government entitlement of 1140 hours per year (38 weeks x 30 hours) on an all year round offer allowing your child to attend our setting for 51 Weeks. Your maximum funding entitlement per week will be 22.35 hours (1140 hours ÷ 51 weeks).

You may be eligible for this if both parents (or the sole parent in a single-parent household) are:

- ✓ in work or starting a new job and earning at least the National Minimum Wage
- ✓ on sick leave or annual leave
- ✓ on shared parental, maternity, paternity or adoption leave

Don't worry if you don't meet the Government's working family criteria, your child will still be entitled to 15 hours of funded childcare from the term after their 3rd birthday.

When should I apply?

When your child turns 9 months:	When you can get your hours from:	When you should apply:
1st Jan - 31st March	Term starting on or after 1st April	Ideally before end of Feb. Deadline 31st March.
1st Apr - 31st Aug	Term starting on or after 1st Sept	Ideally before end of July. Deadline 31st August.
1st Sept - 31st Dec	Term starting on or after 1st Jan	Ideally before end of Nov. Deadline 31st December.

If you wish to use your entitlements later than the term after your child turns the relevant age, you can apply closer to the time you wish to start. Provided you still meet the eligibility criteria for that entitlement at that time, you will not lose your ability to apply.

15 hours universal funded childcare for all families in England



Tell me more...

All 3 and 4-year-olds who live in England are entitled to this offer, irrespective of income levels, benefit status, or family circumstances. This entitles families to up to 570 funded hours per year (38 weeks x 15 hours) on an all year round offer allowing your child to attend our setting for 51 Weeks. Your maximum funding entitlement per week will be 11.17 hours (570 hours ÷ 51 weeks).

When should I apply?

Because this offer is for all families, you do not need to apply as your child will automatically receive these hours from the term after they turn 3.

When your child turns 3 years old:

How can I apply?



1. Check if you're eligible

Find out whether you meet the Government's criteria [here](#).

2. Check when to apply

You'll need to apply the term before you want to start using your funded hours.

3. Apply for your childcare code*

If eligible, you'll be given an online childcare account and a code for your funded hours. **Apply here.** If you're using Tax-Free Childcare, you'll receive your code after reconfirming your entitlement.

4. Share your code with us*

Send us your code along with your National Insurance number and your child's date of birth. We'll check that everything is valid and ready to go.

5. Complete your parent declaration form

We've made this process quick and easy by using Funding Loop, our secure digital system for funding forms.

6. Start using your 15 or 30 hours

We'll claim the funding directly from your local authority and apply it to your invoice.

7. Reconfirm every 3 months

You'll need to **reconfirm your details every three months** to keep your code active. Don't worry, you'll get a reminder when it's time.

**Please note: Steps 3 and 4 aren't required if you're only claiming the Universal Entitlement (15 hours for children aged 3 and over).*

Government funding is designed to deliver free, high-quality childcare. It is not intended to cover the cost of meals, drinks, snacks, nappies, and other consumables, additional hours, or enrichment activities. To support this, a consumables charge is applied to funded sessions - contributing towards the many resources your child uses and benefits from each day.



This charge is carefully broken down into three areas, all detailed over the following pages, so you can see exactly how we support your child's nursery journey every step of the way.



To keep things as all-inclusive and convenient as possible, everything listed across the next three pages is included within your nursery fees and consumables charge (where applicable) as standard. If you would prefer your child not to access consumables alongside their funded hours, please refer to our **Nursery Consumables Policy** and provide one full term's written notice, received no later than the working day before the new term begins. Your nursery manager will then guide you through the next steps.

Meals, enrichment and other charges

Tax-Free Childcare



Tax Free Childcare is quite literally what it says on the tin: a government scheme designed to help working parents with childcare costs. With this scheme, the government pitches in **£2** for every **£8** you spend on childcare, up to a maximum of **£2,000 per year per child** (or **£4,000** if your child has a disability). The best part? You can combine Tax-Free Childcare with all other funding options to further reduce your nursery expenses.
